We only use information specifically provided by applicants for the processing of grants, we do not actively collect information for any other reasons.

We currently collect and process the following information:

- Personal identifiers
- Name
- Address
- Telephone number
- Email address
- Financial details: bank account details explicitly for the submission of grant claims to enable payment

# How we get the personal information and why we have it

All the personal information we process is provided to us directly by you for one of the following reasons:

- To enable a grant funding application to be made
- To enable grant claims to be made
- To contact an applicant regarding an application or claim

We use the information that you have given us in order to apply for grants and to submit grant claims for payment.

We will share this information with the Marine Management Organisation (MMO) who administer the current scheme on behalf of the Department of Environment, Food & Rural Affairs (Defra). The MMO have a 'Disclaimer Statement' which must be

read and confirmation of this provided by yourself in order to proceed with any applications.

### How we store your personal information

We keep the following personal information listed for the duration of your application and until the claim is successfully settled:

- Personal identifiers
- Name
- Address
- Telephone number
- Email address
- Financial details: bank account details explicitly for the submission of grant claims to enable payment

This information is stored on a PIN protected laptop, only used for business purposes and accessible by only one person. The laptop does not leave our premises which are secured when not attended.

Information which is time expired on completion of an application and payment of a claim will be disposed of using the following means:

- The specific folder containing the files created to store your application and claim documentation will be deleted.
- The deleted folder and files will be located in the 'Recycle Bin' and deleted permanently from this location.
- Generally, we do not print application and claim information however if we do these documents will be shredded or burnt.

# Your data protection rights

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.

**Your right to rectification** - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
